Multifamily Consolidated RFP 2023 Program Timeline (2024 Allocations)

January 31, 2023: Deadline for Developers to submit letter of interest to the Housing and Redevelopment Authority of Duluth (if project seeking section 8 voucher rent subsidy support).

March 6, 2023: Deadline for Developers to submit proposals to St. Louis County (if housing project to include local Supportive Housing support).

March 10, 2023: Deadline for Developers to submit pre-commitment requests for HUD FY 2024 Community Development funding to City of Duluth Community Development Committee (contact City of Duluth).

March 21, 2023: Community Development Committee Meeting; review any projects seeking funding pre-commitment support.

March 31, 2023: Deadline for Developers to submit proposal to Housing and Redevelopment Authority of Duluth (if project seeking section 8 voucher rent subsidy support).

April 1, 2023: Deadline for Developers to submit project proposal summary to City of Duluth (if not seeking HUD Community Development Funding; see deadline above if seeking pre-commitment).

April 12, 2022: MN Housing publishes 2023 Consolidated RFP for 2024 Housing Tax Credits, Intent to Apply, and application materials .

April 18, 2023: Affordable Housing Coalition reviews local proposals and provides project endorsement (St. Louis County Housing Support Advisory Council and Heading Home Advisory Council to attend). Developers to provide overview of project to coalition members.

April 19, 2023: St. Louis County Housing Support Advisory Committee meeting to recommend project proposals.

April 20, 2023: St. Louis County Heading Home Advisory Committee meeting to recommend project proposals.

May 8, 2023: Duluth City Council reviews and approves project support via resolution.

May 11, 2023: MN Housing Intent to Apply deadline for eligible Multifamily applications.
