NEW BUSINESS:

NORTHEAST ENTREPRENEUR FUND (EFUND COMPANIES TO WATCH IN 2024) – APPLICATION FOR A TEMPORARY ON-SALE LIQUOR LICENSE FOR 350 HARBOR DRIVE ON OCTOBER 25, 2023. *Commissioner Tynjala moved to approve and was seconded by Commissioner Green. The motion passed unanimously.*
