Alcohol, gambling and tobacco commission discussion of 5/5/2010: Tim Nelson was present on behalf of the application. Mr. Nelson explained that are planning on opening a new restaurant and pub in downtown Duluth in the old city hall building and hope to be open early fall. He continued saying they will be serving sandwiches and alcoholic beverages on the second floor of the building which is the Superior Street level. Ms. Lutterman clarified that the licensed premises will be the basement, second floor and one half of the third floor which the city is satisfied that all levels are compact and contiguous. Mr. Nelson further explained that the third floor is the old council chambers which has a great view of Lake Superior and they plan to use half the space on that floor for banquets or receptions. He also stated that they plan on putting tables and chairs for a bar down in the basement level. Officer Vang stated he has approved the application. There being no further discussion, Mr. Peterson moved that THE APPLICATION OF JUST TAKE ACTION, INC. (DULUTH TYCOON'S), 132 EAST SUPERIOR STREET, FOR AN ON SALE INTOXICATING LIQUOR LICENSE (NEW), ON SALE SUNDAY LICENSE AND APPLICATION FOR A 2:00 A.M. BEVERAGE LICENSE FOR THE PERIOD BEGINNING SEPTEMBER 1, 2010, AND ENDING AUGUST 31, 2011, WITH TIM NELSON, 50 PERCENT STOCKHOLDER, AND ROD RAYMOND, 50 PERCENT STOCKHOLDER, BE APPROVED AND THE SAME BE RECOMMENDED TO THE CITY COUNCIL FOR APPROVAL.
