

The Safe Schools for All Act

The Bill: Minnesota law currently requires school districts to have harassment/violence policies related to conduct based on sex, religion, or race. This provision would have required school districts to have model policies that prohibit harassment, violence and bullying based on actual or perceived race, color, creed, religion, national origin, sex marital status, disability, socioeconomic status, sexual orientation (gender identity and expression), age, physical characteristics, and association with a person or group with one or more of these actual or perceived characteristics.


