
CITY PROPOSAL:

ROSE GARDEN ENTERPRISES, LLC, (VALENTINI'S VICINO LAGO), 1400 LONDON ROAD - APPLICATION FOR TEMPORARY EXPANSION OF THEIR ON SALE INTOXICATING LIQUOR LICENSE FOR SEPTEMBER 3, 2011.

Carol Valentini was present on behalf of the application. Ms. Valentini explained this application is for a wedding reception and will be setting up two tents in the parking lot to allow the alcohol to be consumed outside but the bar will only be inside. To questioning from the commission, Ms. Valentini replied that she has talked to the police department about security, and the reception will be done outside by 8:00 p.m. There being no further discussion, Mr. Donahue moved THAT THE APPLICATION OF ROSE GARDEN ENTERPRISES, LLC, (VALENTINI'S VICINO LAGO), 1400 LONDON ROAD, FOR TEMPORARY EXPANSION OF THEIR ON SALE INTOXICATING LIQUOR LICENSE FOR SEPTEMBER 3, 2011, BE APPROVED, AND THE SAME BE RECOMMENDED TO THE CITY COUNCIL FOR APPROVAL. Mark Glad was present on behalf of the application. Mr. Glad explained that this application is in conjunction with the Hillfest Celebration sponsored by the Neighborhood Housing Services. He continued saying that this will be the second year of the event with the event being bigger and lasting longer.
