STATEMENT OF PURPOSE: This resolution increases the city's fine hot mix contract with Northland Constructors of Duluth, LLC, by \$250,000, payable from the street improvement program fund, for a total contract amount of \$891,562.08. The increase is due to additional costs from the 2011 Pothole Reduction Program previously approved by the city council.

The city's other hot mix contract with Ulland Brothers, Inc., will be decreased by \$250,000.

These materials will be picked up by Duluth city personnel as needed during the contract year for street improvement projects.

The purchasing division issued this award as part of a bid process under a joint powers agreement with St. Louis County. The county's bid tabulation is attached to this resolution.
