
RESOLUTION AUTHORIZING THE PURCHASE AND DELIVERY OF FOUR  
(4) VEHICLES FROM THANE HAWKINS POLAR CHEVROLET IN THE  
AMOUNT OF \$114,863.24.

CITY PROPOSAL:

RESOLVED, that the proper city officials are hereby authorized to contract with Thane Hawkins Polar Chevrolet for the purchase and delivery of four (4) vehicles - one (1) 2012 Chevrolet Tahoe Special Service UV33 4x4 unit, one (1) 2012 Chevrolet Silverado 3500 HD 4x4 regular cab and chassis unit, one (1) 2012 Chevrolet Colorado 4x4 crew cab pickup truck, and one (1) Chevrolet Silverado 2500 4x4 extended cab long box pickup - all in accordance with Minnesota state contract specifications and pricing, for a total of \$107,568.95 plus \$6,991.99 state vehicle sales tax (6 1/2%) plus \$302.30 license, registration, and tax-exempt plates and fees, for a combined total of \$114,863.24, payable as follows:







STATEMENT OF PURPOSE: This resolution authorizes the purchase of four vehicles from Thane Hawkins Polar Chevrolet for \$114,863.24, payable from the capital equipment fund.

The 2012 Chevrolet Tahoe has special equipment for use as a marked police patrol vehicle. The 2012 Chevrolet Silverado 3500 replaces unit 3320, a one-ton crew cab truck sold at auction in May 2011. The 2012 Colorado replaces unit 9162 Dodge Durango for the radio shop. The 2012 Silverado 2500 is a new pickup for the parks department.

Thane Hawkins Polar Chevrolet is located in White Bear Lake, Minnesota.
