CITY PROPOSAL:



Chasers of Duluth, Inc. (Bedrock Bar), 2023 West Superior Street, for June 16, 2012, from 5:00 p.m. to 9:00 p.m.

The Lake Effect Restaurant, Inc. (Lake Avenue Café), 394 Lake Avenue South, for June 15 and 16, 2012, with music and serving ceasing at 1:00 a.m.

Alcohol, gambling and tobacco commission discussion of 5/3/2012:

**GRANDMA'S ANGIE'S, INC, (LITTLE ANGIE'S CANTINA), 11 E BUCHANAN ST.** - APPLICATION FOR TEMPORARY EXPANSION OF THE LICENSED PREMISES OF THEIR ON SALE INTOXICATING LIQUOR LICENSE FOR JUNE 16, 2012.

Tony Bronson was present on behalf of the application. Mr. Bronson stated that they would like to be able to set up a bar and table and chairs on the sidewalk in front of the deck during the marathon where they put up a fajita stand and serve beer. He went on to explain that they are further requesting to keep the table and chairs out on the sidewalk after the street opens up in order to keep serving food and alcohol on the bricks and will put up fencing to contain the area as was done last year. The clerk stated that there will be a second special events license closing that area of the sidewalk that will allow the licensee to enclose that area of the sidewalk. Mr. Bronson explained that because they are required to allow people to walk through the deck area without having to eat and drink, by having the area on the sidewalk it helps keep the access onto the deck and into the restaurant much easier. To questioning by the commission, Mr. Bronson replied that they would like to serve in both areas until 2:00 a.m. To questioning from the commission, Officer Vang replied the security arrangement have been approved and the application has also been approved. There being no further discussion, Mr. Birchland moved that THE APPLICATION OF GRANDMA'S ANGIE'S, INC. **CHASERS OF DULUTH, INC. (BEDROCK BAR), 2023 W. SUPERIOR ST** - APPLICATION FOR TEMPORARY EXPANSION OF THE LICENSED PREMISES OF THEIR ON SALE INTOXICATING LIQUOR LICENSE FOR JUNE 16, 2012.

Tammy Benson was present on behalf of the application. Ms. Benson explained that the Lincoln Park business district is having their annual fishing tournament, and they would like to use their parking lot for the awards program that night. To questioning from the board, Ms. Benson replied that they are using the parking lot which will be contained by snowfencing which will allow for the overflow of people that the tournament will bring to the bar. She continued saying they are having an outside bar and will have off an duty police officer checking ID's at the bar. To further questioning, Ms. Benson replied that the event will be from 5:00 p.m. to 9:00 p.m. Officer Vang stated that he has approved this application. There being no further discussion, Mr. Hickok moved that THE APPLICATION OF CHASER'S OF DULUTH, INC, (BEDROCK BAR), 2023 W. SUPERIOR ST., FOR TEMPORARY EXPANSION OF THEIR ON SALE INTOXICATING LIQUOR LICENSE FOR JUNE 16, 2012, BE APPROVED, AND THE SAME BE RECOMMENDED TO THE CITY COUNCIL FOR APPROVAL. Mr. Stauber seconded the motion, and it was unanimously approved.

**THE LAKE EFFECT RESTAURANT, INC. (LAKE AVENUE CAFÉ), 394 LAKE AVENUE SOUTH** - APPLICATION FOR TEMPORARY EXPANSION OF THE ON SALE INTOXICATING LIQUOR LICENSE AND TEMPORARY ON SALE DANCE LICENSE FOR JUNE 15 & 16, 2012.

Derek Snyder was present on behalf of the application. Mr. Snyder explained that on the Friday and Saturday night of Grandma's Marathon, they would are setting up a large tent in their parking lot behind the DeWitt Seitz Building. He explained that they will have several bands playing each night in the tent and will be using wrist bands to identify those over 21. To questioning from the

commission, Mr. Snyder replied that he has talked to the police department and has arranged for security to work at the event checking ID's. He also stated that they will be closing down at the same time as the marathon tent which is 1:00 a.m. Officer Vang has approved this application.
