STATEMENT OF PURPOSE: This resolution authorizes the proper city officials to enter into an Addendum to Contract No. 20956 with St. Louis County under which the Workforce Development Division provides employment and training services to MFIP participants. The funding for these services was authorized by the Minnesota legislature as part of the Supported Work Program. Under the terms of the original Agreement with St. Louis County, the funding from the County was expected to be \$80,102.40; however, in no case will the amount of funding exceed the County's total allocation for Supported Work, \$240,307.50. The term of the Agreement was July 1, 2011 through June 30, 2012. However, due to the State

government shut-down in July of 2011, there is an agreement to extend the end date of the contract from June 30, 2012 to September 30, 2012 to enable the City additional time to spend its allocation.

ADDENDUM - CONTRACT NO. 20956

WITNESSETH

WHEREAS, the **ST. LOUIS COUNTY BOARD** and the **CITY OF DULUTH**, 332 City Hall, 411 West First Street, Duluth MN 55802 entered into an agreement, hereinafter called the "Contract", for the provision of providing **Supported Work** for the period July 1, 2011 through June 30, 2012; and

WHEREAS, the parties desire to amend the Contract so as to enable both parties to continue to enjoy the mutual benefits it provides by amending its allocations; and

WHEREAS, paragraph 15-b of the Contract provides that any amendments shall be valid only expressed in writing and duly signed by the parties;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and for other good and valuable consideration, the parties further agree as follows:

1. Due to the State government shutdown in July 2011, Board agrees to extend the end date of this contract from June 30, 2012 to September 30, 2012 to enable the City additional time to spend their allocation.
2. That all other provisions of the original Contract, except as amended herein, shall remain in full force and effect.
