RESOLUTION AUTHORIZING ANNUAL BANKING SERVICES WITH BMO HARRIS BANK, N.A., (FORMERLY M&I MARSHALL & ILSLEY BANK) FOR AN ESTIMATED TOTAL OF \$90,000 IN YEAR 2013.

CITY PROPOSAL:

RESOLVED, that the proper city officials are authorized to execute a renewal of Agreement 21491 with BMO Harris Bank, N.A., formerly M&I Marshall & Ilsley Bank, with no change in banking services, for an estimated total of \$90,000 in year 2013, payable as follows:

- \$23,400 Water Fund 510, Dept./Agency 500 (Public Works & Utilities), Div. 1940 (Customer Services), Cost Center 2400 (Customer Accounts), Obj. 5310 (Contract Services);
- \$35,100 Gas Fund 520, Dept./Agency 500 (Public Works & Utilities), Div. 1940 (Customer Services), Cost Center 2400 (Customer Accounts), Obj. 5310 (Contract Services);
- \$20,700 Sewer Fund 530, Dept./Agency 500 (Public Works & Utilities), Div. 1940 (Customer Services), Cost Center 2400 (Customer Accounts), Obj. 5310 (Contract Services);



STATEMENT OF PURPOSE: This resolution authorizes the renewal of banking services as described in Agreement 21491 with BMO Harris Bank, N.A. (formerly M&I Marshall & Ilsley Bank) for an estimated \$90,000 in year 2013. These services include credit card processing, ACH (automated clearing house) transactions, lockbox depository services, online payment processing, and depository services.

The purchasing division posted the original request for proposals (RFP) on the city's website on April 16, 2010, mailed RFPs to three local vendors, and received three responses by the closing date. An internal committee of financial experts evaluated responses and determined that M&I Marshall & Ilsley Bank offered the best proposal for the most reasonable price. BMO Harris Bank has since acquired M&I Marshall & Ilsley Bank.

The city council has previously taken the following actions:
