

The clerk stated that any licensee that has delinquent sales and property taxes would have to have them paid in full by April 30 in order for them to continue selling alcohol on May 1. There being no further discussion, Mr. Hanson moved that THE RENEWAL APPLICATIONS FOR OFF SALE 3.2% MALT LIQUOR LICENSE RENEWALS BE APPROVED, SUBJECT TO ALL SALES AND PROPERTY TAXES PAID IN FULL BY ALL LICENSEES BY APRIL 30, 2013, AND THE SAME BE RECOMMENDED TO THE CITY COUNCIL FOR APPROVAL. Mr. Rosenthal seconded the motion and it was unanimously approved.
