FLAME NIGHTCLUB, INC. (FLAME NIGHTCLUB), 28 N 1<sup>ST</sup> AVENUE WEST, - APPLICATION FOR PERMANENT EXPANSION OF THE ON SALE INTOXICATING LIQUOR LICENSE FOR THE PERIOD ENDING AUGUST 31, 2013.

Vince Nelson, owner, and Kristin Looney, manager, were present on behalf of the application. Ms. Looney explained they would like to have an extension of their licensed premises so their patrons can bring their drinks with them when they go out for a smoke onto the deck. She stated that currently they use the upper deck for smoking, but there is security posted at the door so that no one can bring their drink out with them. Ms. Looney stated that there is a deck on each floor of the building, and the first floor deck will have a gate on it so that no one will be allowed off the deck with their drink, and there will be security also on the deck. To the clerk's questioning, Mr. Nelson replied that the first floor will be open within the next few weeks which will allow access to the first floor deck. To questioning from the commission, Ms. Looney replied that they haven't had any complaints from neighbors from people using the deck for smoking.

Officer Vang voiced concern on behalf of the police department on the application. He explained he did a comparison on complaint calls between the Flame Nightclub and Aces. He explained the bars are close in proximity and Aces has a younger crowd that could potentially generate more complaints. Officer Vang reviewed that from August 2012 to July 2013, the Flame generated 120 service calls and Aces had 64 as shown on the handout given to the commissioners. He continued saying that when reviewing these types of calls, the department looks to see whether the management could have controlled some of the incidents from happening and it appears that the management was not in charge of their customers. Officer Vang explained that the police department is concerned that an establishment with many service calls already and adding a different environment such as the deck could create more disturbances outside, especially for the owners and tenants of the buildings on the block.

Ms. Looney replied that they have hired a new head of security who started in July and has cracked down on a lot of things and they have already noticed a better change with fewer disturbances in and outside of the bar. She stated that they are always trying to improve the situation and meeting with staff to see what they can do to make it better. Mr. Nelson reviewed that they did have some noise complaints when they first opened when they would open their windows at night, but they have since put in more air conditioning so they don't need to open the windows any more. He also reviewed they are expanding their inside space by opening up the lower level of the building to help keep the disturbances off the street. Mr. Nelson stated the community police officer has not notified him in the last few months of any calls or concerns from the police department. The commission questioned what security do they have on a nightly basis, and Ms. Looney replied they had an off duty police officer on weekends and security every night.

Officer Vang stated while it is good they have a new head of security, there is no track record from July in which to evaluate. He continued saying that the recommendation of the police department is not to approve this application at this time.

There being no further discussion, Mr. Stauber moved for denial of the application based on the recommendation from the police department, the high number of calls for service over the past year, and suggested the applicant reapply in 60-90 days. Mr. Braaten seconded the motion, and it was unanimously approved.

Expansion area is an existing patio adjacent to the rear of building off the first and second level of the building.

The second level is 44ft x5ft currently used as a smoking and seating area. First level is 24ft by 5ft adjacent to our 1<sup>st</sup> floor bar area.


There is a gate, security cameras and security personnel stationed at both of the exits.








