NOW THE CONDITION OF THIS OBLIGATION IS SUCH, that if the said Principal shall be granted a permit for street obstruction and/or moving or wrecking a structure located at _____ in the City of Duluth, and shall perform and complete all work for which said permit is issued in accordance with all ordinances of the City of Duluth within a "reasonable time" as set forth in Section 10-4 of the Duluth City Code; and shall perform all street obstruction work in conformance with all ordinances, rules and regulations of the City; and shall restore any street or sidewalk damaged or excavated by him or his agents, employees or subcontractors to its prior condition; and shall reimburse the City of Duluth for all damages to any City property resulting from any work operations done pursuant to such permit; and shall save the City of Duluth harmless from any and all claims resulting from the work operations, regardless of whether such damage is done by himself, his agents, employees or subcontractors; then this obligation shall be void, otherwise it shall have full force and effect.
