Sealed bids will be received by the City Purchasing Agent in and for the Corporation of the City of Duluth, Minnesota, at his office, Room 100 City Hall, Duluth, Minnesota, 55802, (218) 730-5340 until 2:00 PM local time on April 17, 2014 for the above named project. Immediately thereafter, bids will be taken to room 106A City Hall, where they will be publicly opened and read aloud.

NOTICE TO BIDDERS:

1) A Project Labor Agreement (PLA) will be required for any bid that is over or could go over \$150,000.
2) Unless a Certificate of Exemption is provided, any out-of-state bidder receiving a bid award will have 8% retained from invoice payments on contracts over \$50,000. Submit a signed copy from the State of Minnesota when submitting Payment and Performance Bonds. This project consists of removal and relocation of a segment of existing Seven Bridges Road due to flood damage caused by the June 2012 flood. The existing road will be removed and relocated along approximately 850 feet of alignment and includes removal of existing pavement, embankment excavation, full depth bituminous pavement construction, culverts, drainage and landscape restoration. The relocation affects the Lester River Ski trail and a portion of the trail will be relocated as part of the project. This work includes electrical lighting along the trail. A failure at a separate location damaged by the flood will also be repaired. At this location, the existing pavement and drainage culvert will be removed and rebuilt using a geogrid reinforcing system.

Each bidder must utilize the 2013 Edition of the "City of Duluth Public Works/Utilities Department – Engineering Division Standard Construction Specifications" booklet as this booklet is incorporated by reference and is deemed to be a part hereof this project as if fully incorporated and set forth herein. Plans and specifications may be secured from the City Engineering office, Room 211 City Hall, 411 West 1st St., Duluth, MN 55802, upon payment of a check, draft or money order in the amount of \$50.00 made payable to the City of Duluth. (This payment will not be refunded.)

Plans and specifications are on file for inspection at the City Engineering office, Duluth Builders Exchange, McGraw Hill Construction (www.dodge.construction.com), Minneapolis Builders Exchange and St. Paul Builders Exchange.

A certified check or bank draft, payable to the order of the City of Duluth, negotiable U.S. Government Bonds (at par value), or a satisfactory bid bond executed by the bidder and acceptable surety, in an amount equal to five per cent (5%) of the total bid, shall be submitted with each bid.

Attention is called to the fact that not less than the minimum salaries and prevailing wages as set forth in the contract documents must be paid on this project. The contractor must take affirmative action to ensure that the employees and applicants for employment are not discriminated against because of their race, color, creed, sex or national origin, and must meet the affirmative action goals. Contractors are encouraged to subcontract with Disadvantaged Business Enterprises when possible.

The project is being financed by FEMA and Minnesota Department of Public Safety. Both Federal Davis Bacon prevailing wages and State of Minnesota prevailing wages apply to this project. Payment of wage and fringe benefits that are most beneficial to the employees are required.
