Proposals will be opened and read publicly by the City Purchasing Agent or his representative at the same room in City Hall in Duluth, Minnesota (**Room 100**) immediately after the hour set for receiving bids.

Minimum wage rates to be paid by the Contractors have been predetermined and are subject to the Work Hours Act of 1962, P.L. 87-581 and implementing regulations.

Unless a Certificate of Exemption is provided, any out-of-state bidder receiving a bid award will have 8% retained from invoice payments on any contracts over \$50,000.
