Informational Packet: Packet from Deputy Chief passed out packets with statistics from the month and the list of complaints.

Started Strategic planning: working through February for next 3-5 years; CRB will be invited to be a part of a focus group; Have an online survey to go with it – will share it with board to help pass it along. Carl is on the planning process team, as well as Phil Jents from Mayor's office and Christina Woods from Damiano Center. This document will be public once it is completed.

Hiring Process: City in budget discussion; DPD is in personnel shortage. Many discussions on how to manage the scenario. Will be able to save the city money and hire 7-8 people by the end of the year. Part of the new hiring process. Tried testing down in the Cities but it has not resulted in officers either staying with DPD or increasing diversity of hires. Will be meeting with local education systems and try to figure out how to incorporate a better plan to mentor student candidates to consider DPD.

Draft of Complaint Policy: Laura will have this re-sent and need to get a date/time for Policy Review committee to meet and review complaint policy. Would like to start doing some audits to follow-up on the policy implementation. Article in DNT on use of Less Than Lethal: Good article about sharing how this was used in a situation in Wisconsin that resolved a situation without the need for a firearm or significant injury to anyone.

Scoring Phase of Records Management Software: RFP – 5 companies have submitted proposals – hoping to get it down to 2 presentations. Laura will invite CRB to be a part of this.
