LAWFUL GAMBLING: Terry Wahlin, volunteer organizer, was present on behalf of the Welch Center (Valley Youth Center) motorcycle run fundraiser. Ms. Wahlin explained to the board that they would be holding a raffle and silent auction with all proceeds going to the Valley Youth Center. They are requesting a raffle exemption, 60 day waver.
